Mr. Sokha, a 30-year-old married man with one daughter, is diagnosed with early-stage lung cancer one year after his policy is in force.

Mrs. Chenda receives US\$14,000, equivalent to 100% of her **Accidental Death or Disability Benefits**, to help her daughter and her lighten their financial burden.

Mr. Rithy, a 40-year-old married man, passes away due to a heart attack four years after his policy is in force.

Mr. Rithy's family receives US\$7,000, equivalent to 100% of his **Non-Accidental Death or Disability Benefits**, to ease their financial burden following the death of their sole breadwinner.

▶ **Mr. Rithy's policy is terminated after his claim is paid.**
